IN 2016, APPROXIMATELY 5,100 INDIVIDUALS IN GROUPS ACROSS THE COUNTRY PARTICIPATED IN JUSTFAITH MINISTRIES' PROGRAMMING. PARTICIPANTS STUDIED AND WERE FORMED BY THE COMPASSION TRADITION ARTICULATED BY THE SCRIPTURES, THE CHURCH'S HISTORICAL WITNESS, THEOLOGICAL INQUIRY, AND CHURCH SOCIAL TEACHING. MANY INDIVIDUALS EXPERIENCED A CONVERSION, INTEGRATING THEIR PERSONAL SPIRITUALITY WITH ACTS OF SERVICE TO THE POOR AND VULNERABLE IN THEIR CHURCH AND IN THE COMMUNITY AT LARGE. PREVIOUS SURVEYS INDICATED THAT OVER 90% OF PARTICIPANTS HAVE AN INCREASED UNDERSTANDING OF ISSUES RELATED TO POVERTY, HAVE AN INCREASED COMPASSION FOR THE POOR AND VULNERABLE, AND ARE COMMITTED TO BECOMING INVOLVED IN SOME SORT OF SERVICE.
