PARTICIPANTS STUDIED AND WERE FORMED BY THE COMPASSION TRADITION ARTICULATED BY THE SCRIPTURES, THE CHURCH'S HISTORICAL WITNESS, THEOLOGICAL INQUIRY, AND CHURCH SOCIAL TEACHING. MANY INDIVIDUALS EXPERIENCED A CONVERSION, INTEGRATING THEIR PERSONAL SPIRITUALITY WITH ACTS OF SERVICE TO THE POOR AND VULNERABLE IN THEIR CHURCH AND IN THE COMMUNITY AT LARGE. PREVIOUS SURVEYS INDICATED THAT OVER 90% OF PARTICIPANTS HAVE AN INCREASED UNDERSTANDING OF ISSUES RELATED TO POVERTY, HAVE AN INCREASED COMPASSION FOR THE POOR AND VULNERABLE, AND ARE COMMITTED TO BECOMING INVOLVED IN SOME SORT OF SERVICE.
